VET

VCE students are able to enrol in a variety of VET courses being offered by the Inner Melbourne VET Cluster.

In addition to a subsidy from the CECV, the cost of the courses are approximately \$400 - \$1,800.

FAMILY DISCOUNTS ON TUITION FEES

Families with more than one child attending the College during 2025 receive a 5% discount on Tuition Fees for their second and any subsequent children.

MID TERM ENROLMENT

For students entering the College for the first time after the beginning of a Term, Tuition Fees will be charged on a proportionate basis.

TERMINATION OF ENROLMENT

A term's notice is required in writing to the Principal prior to the departure of a student from the College. Without this notice, a term's fees will be charged.

PAYMENT OPTIONS

The option to select a payment plan for 2025 fees, will be available via the Finance Page in the Parent Portal from 30 October 2024 - 22 November 2024. If you are outside this timeframe, please contact the Finance Office for assistance. The most recent selected payment plan will carry forward to 2025. The College portal is located:

2025 PAYMENT PLANS OPTIONS

1. **Monthly Payment Plan** (default option): in ten (10) monthly instalments commencing 15 January 2025 and ending on 15 October 2025.
2. **Advance Payment**: full payment of fees for 2025 before 15 December 2024, will be offered a 3.75% reduction on the Tuition Fees amount due (excluding building levy, camp and Old Collegian levies, Payroll Tax Levy and optional charges).
3. **Quarterly Billing Plan**: four (4) equal payments due on 15 January 2025, 15 April 2025, 15 July 2025 and 15 October 2025.

Please note optional associated charges (Music, Swimming, Diving, Rowing camps) will need to be paid on their respective due dates, via your Sundry Account, which is separate to your Fee Account.

LATE FEE AND OTHER CHARGES

An administrative charge for late payment of \$250 will be levied where a family fails to make a valid payment by the chosen payment plan due date and where no prior advice has been provided to the College.

A dishonour fee will apply for any declined payments.

METHODS OF PAYMENT

Tuition Fees and other associated charges can be paid by the following methods:

1. **Preferred method**: The College can administer your payment plan via direct debit of a bank account or credit card (a 1% surcharge applies).
2. **BPAY**: Biller code is 57604. The reference number is shown on the front of your statement.
3. **Parent Portal**: Payment can be made by direct debit via bank account or credit card.
4. **Direct Deposit**: Ensure your **Account ID** shown on the front of your statement is used as your reference to **BSB: 063 162, Account number: 00160545**.
5. **Cheque**: Payable to St Kevin's College Ltd.
